The certification should comply with the document <i>Rules and Procedures for Toll Management System and Products Certifications</i> STQC/TMSPC/D01, available on the STQC website at link: https://www.stqc.gov.in/toll-management-system-products-certification-scheme</p> <p>Applicants currently undergoing STQC certification or in the process of applying in any of the STQC Labs / Centres mentioned at https://www.stqc.gov.in/labs-centres may be considered for provisional empanelment only up to 31.07.2025, subject to submission of documentary proof (copy of challan/acknowledgement from STQC Lab/Centre).</p> <p>In the event that the Applicant fails to submit a valid STQC certificate by 31.07.2025, the empanelment shall stand automatically revoked w.e.f 01.08.2025. Furthermore, the System Integrator shall be barred from applying for fresh empanelment for a period of six months from the date of such revocation.</p> <p>For the avoidance of doubt, it is hereby clarified that no provisional empanelment shall remain in effect beyond 31.07.2025 and a System Integrator shall be considered</p>
